- Proved the concept that fingerprints can assist and support criminal record exchange
- Created momentum in a change of opinion towards fingerprints
- Identified the need and opportunity for future development in this area

EFEN Project Objectives

Support implementation of CFD 2009/315/JHA across the EU with a particular focus on article 11(c)

Raise awareness and mutual understanding of the different judicial systems and associated importance of identification in criminal records exchange through networking with the

EU judicial community

Support implementation of CFD 2008/675/JHA across the EU with a particular focus on identity and its importance in the use of previous convictions in criminal proceedings

Develop and share best practice in relation to utilising fingerprints within criminal records exchange through the establishment of an ECRIS fingerprint practitioner network and at workshops with EU MS

Promote harmonisation between all EU MS and relevant accession countries by supporting integration into exchange processes within ECRIS with a particular focus on judicial cooperation with regard to the use of fingerprints as a part of EU criminal record exchange

SEFEN Work Stream 1

Objective 1 of 5...

 Visit every EU MS to share best practice of using fingerprints within criminal record exchange between EU MS

- ✓ Workshops held with 21 MS
- ✓ Engaged with criminal records and fingerprint representatives
- Best practice shared by presentations
- ✓ CIRCABC used to further share best practice after workshops

Objective 2 of 5...

 Identify the potential gaps in linking fingerprints with criminal record exchange within the EU so the European Commission can make an informed decision on the need for further CFDs in this area

Achievements...

- ✓ Questionnaire and workshop data collected from 25 MS
- ✓ Data analysed to understand the situation in more detail
- √ Findings summarised in a report

Objective 3 of 5...

Identify practitioners and establish an ECRIS fingerprint
practitioners network to provide an open forum to debate
the use of fingerprints within ECRIS in order to develop a
mutual understanding between MS

- ✓ Practitioners identified and invited
- √ 3 meetings have been held so far
- ✓ 9 MS attended
- ✓ All information published on CIRCABC

Objective 4 of 5...

 Consider options to sustain the network beyond the life of the project

Achievements...

- Agreement by MS that this should continue
- ✓ sustainability is currently being discussed

 Further develop the recommendations of the MUCRI Project relevant to identification issues and the sharing of best practice

- ✓ Considered previous projects and recommendations including MUCRI
- Addressed in the work stream report

FEFEN Work Stream 2

Objective 1 of 3...

 Refine the UKCA-ECR electronic process for incoming fingerprints from EU MS

- ✓ New system developed for processing incoming FP via ECRIS
- ✓ Interface between UKCA-ECR and AFIS
- ✓ Process now electronic

Objective 2 of 3...

Reduce the amount of time it takes to check the identification of fingerprints through ECRIS

Achievements...

- ✓ Evaluation completed
- ✓ Reviewed original process time to new process time
- ✓ Considerable time and cost savings identified

 Share the experiences of implementing the new process with EU MS so that the project can inform best practice in this area

- Implementation process reported
- ✓ Evaluation results report
- Shared on CIRCABC and at conference
